SPOC Update

As Louisiana's SPOC, I will continue to ensure that the unique needs and expectations of our public safety personnel are communicated to FirstNet planners and to their network partner, once chosen through the recently released RFP. Last week I met in New Orleans with FirstNet and Louisiana law enforcement leaders. Network planners heard firsthand the concerns and expectations of Louisiana's law enforcement community. I remain committed to our fire, EMS, 911/PSAP, law



enforcement and emergency management communities and will continue to help plan for a network that will serve their needs in every corner of our State.



FirstNet Focus: Request for Proposal (RFP)

FirstNet has met a significant milestone by issuing the RFP . The RFP will pave the way for FirstNet to develop a partnership to deploy the Nationwide Public Safety Broadband Network. The criteria to be met by potential partners is outlined within the 500 plus page document.

Each potential partner will furnish a comprehensive solution to deploy the network including personnel, materials, services, facilities, management and other resources necessary to perform the objectives set forth in the request. The potential partner will be evaluated by their ability to meet the criteria and build and operate the nationwide public safety network.

There is a new webpage on the LA FirstNet website dedicated to the this RFP. The page provides easy access to the text of the RFP, the RFP webinar presentation, and access to the FirstNet reading room with detailed state content. Opportunity for Input:

FirstNet has announced their three pronged outreach and consultation approach for 2016. Our LA FirstNet staff will work with them to achieve the following goals:

- Governance Body Outreach—FirstNet is planning to meet with governance bodies in every state and answer any questions about their RFP and the process they are going through to partner with a network partner to build the NPSBN. FirstNet plans to be present at our April 2016 SIEC meeting. Details will be in our next newsletter and on our website firstnet.louisiana.gov
- Executive/Key Stakeholder Outreach—FirstNet is looking to the states to identify who will be critical to the Governor's opt-in or opt-out decision and will make themselves available to work with those stakeholders and through the SPOC to make sure those stakeholders are as informed as possible about FirstNet and the proposed network
- Consultation Task Teams—We will identify discipline specific teams to work with First-Net to reach out and/or be available to each public safety discipline for issues, guestions or concerns.
