

LA FirstNet Focus: **NTIA's State Alternative Plan** Program aka "Opting Out"



In the coming year, each state will decide whether to either accept FirstNet's plan for its state and allow the buildout to proceed pursuant to FirstNet's plan or provide notice of its intention to reject FirstNet's plan and proceed with building its own RAN.

If choosing to build, operate and maintain their own RAN:

First, a state must submit its alternative plan for the construction, maintenance, operation and improvements of its RAN to the Federal Communications Commission (FCC) and meet specific interoperability criteria established by the FCC.

Second, if FCC approves the state-developed plan, the state must then **apply** to NTIA for the authority to enter into a spectrum capacity lease with FirstNet to operate its RAN within the state.

Third, assuming the state has successfully made such demonstrations to NTIA, the state then must negotiate and enter into a spectrum capacity lease with FirstNet, which will be required for operation of the state RAN. A state receiving approval of its alternative plan from the FCC and NTIA may, but is not required to, apply to NTIA for grant funds to assist in the construction of its RAN.

These three steps are fundamental to achieving a core goal of the Act, which is ensuring that the NPSBN, regardless whether FirstNet or a state assumes responsibility for the RAN, will interoperate, provide seamless broadband service across the nation, and be financially and technically sustainable.

PSAC Completes ICAM & **Local Control Task Teams**

At the request of FirstNet, FirstNet's Public Safety Advisory Committee (PSAC) launched two Task Teams in early 2016 to address critical topics related to the eventual deployment of the nationwide public safety broadband network (NPSBN): **Identity, Credential and Access** Management (ICAM) and Local Control. Captain Chris Lombard from the Interagency Board chaired the ICAM Task Team, while Barry Fraser from the National Association of **Telecommunications Officers and Advisors** chaired the Local Control Task Team.
